- 2. Bidders must be on the Active Tax Payer List as published by FBR

Tender Document (for details) may be collected after submission of the paid fee challan from the Procurement Department, IoBM, Korangi Creek during working hours. (09:00 - 16:00 hrs, Monday to Thursday & Saturday). Alternatively, the tender document can be downloaded from the website. Bids will be opened on the said date & venue in the presence of the bidders' representatives who may wish to attend. Kindly mention "Tender Number" at the top left corner of the envelope. IoBM reserves the right to reject or accept any bid or cancel the bidding process.

TERMS & CONDITIONS

- 1. IoBM may reject all bids at any time prior to the acceptance of a bid.
- 2. 2% Performance Security should be deposited on the total cost of the quoted amount in the shape of a pay order drawn in favor of the Institute of Business Management (after the tender award). This amount will be released 6 months after successful completion as certified by the IoBM IT Team.
- 3. Copies of the Sales Tax Registration and NTN are to be attached to the bidding documents.
- 4. The quoted rates shall be inclusive of all applicable Govt—taxes and charges, which should be separately shown.
- 5. The purchase committee reserves the right to reject or accept any bid without assigning any reason and the decision of the Committee shall be final.
- 6. The bidders are requested to submit their bids along with the bid validity period (not less than 90 days)
- 7. Complete product specification/information to be provided by the bidder
- 8. Rates shall be quoted in Pak rupees, with the exchange rate used for calculation should be clearly stated.
- 9. The method of procurement is on open competitive bidding single-stage Two envelope procedure. (Technical & Financial)
- 10. The rates to be quoted shall be filled in the bidding documents mandatorily.
- 11. Tender Fee of Rs 2000/- Non-refundable (In the form of Pay Order drawn in the name of Institute of Business Management)
